Terms and Conditions

Your Contract

When you book your itinerary, the terms set out below form the basis of your contract between Old Burma Tour & Trading Company (“the Company”) and you and your party. The contract is concluded only when the Company confirms your booking. The person who makes the booking is responsible for everyone included in the booking.

Confirmation of Booking and Payment

Booking may be made by contacting the Company directly, or through a registered travel agent. If booking is made through a travel agent, an additional 15% fee will be added to the cost of the itinerary to cover commission and administrative costs. For booking made directly with the Company, payment is accepted only in cash or by check. Bookings are confirmed with receipt of a 50% deposit on the cost of the itinerary. The Balance is due four weeks prior to departure. Failure to receive final balance prior to departure may result in cancellation by the Company and subject you to the cancellation fee as calculated below.

Cancellation and Changes

The Company will do its best to accommodate any changes you may request after your confirmation has been sent. If an amendment or cancellation by you or any member of your party is necessary, this must be confirmed in writing and a fee is payable by you to the Company, on the following scale:

Written Notice Received Before The Scheduled Departure Date	Cancellation Fee	Amendment Fee
56 Days or more	15% / Deposit	One Free then 10%
21-55 Days	30%	20%
2-20 Days	75%	25%
Within 2 Days	100%	30%

*fees are expressed as a percentage of the itinerary cost

Surcharges

The price quoted to you is based on known costs and exchange rates at the time of booking and the Company does not expect to have to make changes. However, the Company reserves the right at any time prior to receipt of the final balance to impose a

surcharge on the price of your itinerary of such an amount as will in the reasonable opinion of the Company compensate the Company for any adverse movement in costs. Any adverse movement in costs after receipt of the final balance will be absorbed by the Company.

Insurance

We recommend travel protection coverage. Old Burma Tour & Trading Company will be delighted refer providers of travel insurance products upon request.

Travel Documents

You are responsible for obtaining any relevant visa or related travel documents. The Company will be delighted to provide contact information and assist in any way to expedite the process. Please allow sufficient time for receipt of travel documents prior to departure.

Luggage

Please ensure that you and any members of your travel party do not carry any substances or articles which are dangerous, may cause harm or inconvenience to other passengers, or are prohibited in any of the countries through which your luggage will be transported. All luggage is carried at your own risk and the Company accepts no liability for any loss of, damage to, or delay to such luggage unless through its own wrongful act or willful neglect.

Liability

The Company accepts responsibility for delivery of all elements of the itinerary as outlined and of a reasonable standard. However, the daily flow of the itinerary is subject to change due to circumstances beyond control of the Company, or because you may request changes. Because circumstances in the country, such as flight schedules, are subject to change without notice, you will be informed of any changes at the time of booking or as soon as reasonably possible.

Changes or Cancellations by the Company

If after your reservation has been confirmed but before departure, a major change to your itinerary becomes necessary, there are various options available to you. 1) accept the changes as given, including any resulting change in pricing. 2) accept the same itinerary on an alternative date. 3) cancel your reservation and receive a full refund. The Company does not guarantee and is not liable in respect to changes or delays to departures or


